## REFUSE HAULING AND COLLECTION FROM COUNTY FACILITIES

**BIDS DUE**: TUESDAY, FEBRUARY 5, 2013, 2:00 PM. DUE DATE AND TIME ARE NOT CHANGED BY THIS ADDENDUM.

This Addendum is issued to modify, explain or clarify the original Request for Bid, (RFB) and is hereby made a part of the RFB, RFP. Please attach this Addendum to the RFB.

All bidders must acknowledge this Addendum on the Bid Form and attach the updated location bid sheets with their bid.

## PLEASE MAKE THE FOLLOWING CHANGES:

- 1. This bid does not require a bid bond. Please cross out "Bid Bond" on the bid check list on page 13 of the Bid Form. Ignore any other reference to a bid bond included in the original document. A Performance/Payment bond is still required for this bid.
- 2. All landfillable refuse collected under this contract shall be disposed of at Dane County Sanitary Landfill Site # 2. It is not acceptable to haul a matching volume/weight of waste from other sources to the county landfill in place of the actual waste collected.
- 3. At the zoo, manure containers will not be in a centralized location for pickup but will be located at their respective buildings.
- 4. Dane County does not wish to convert to single stream containers at any location where sorted recycling is specified. Dane County will not accept alternate bids or pricing for changing to single stream recycling at locations where sorted recycling containers are specified.
- 5. Photo evidence will be required when any load is rejected due to hazardous contents as described in item 7 of the Scope of Work section or due to contamination in a load of recyclables.
- 6. Reports detailing amount of material recycled shall be submitted to Dane County Monthly. Dane County reserves the right to audit and investigate to verify these quantities.
