#### DANE COUNTY JCO / NIP SECURITY UPGRADES

**<u>BIDS DUE</u>**: TUESDAY, MAY 25, 2021, 2:00 PM. DUE DATE AND TIME ARE NOT CHANGED BY THIS ADDENDUM.

This Addendum is issued to modify, explain or clarify the original Request for Bid (RFB) and is hereby made a part of the RFB. Please attach this Addendum to the RFB.

#### PLEASE NOTE RESPONSES TO THE FOLLOWING BIDDER-SUBMITTED QUESTIONS

- Q1: Is fire treated lumber required for concealed blocking? Sheet G003 note 4 calls out that it does not, but spec. calls for all concealed blocking to be fire treated. Please clarify.
- A1: Yes, concealed blocking is to be fire retardant treated since the building is classified under IBC 2015 as Type IIB construction.
- Q2: What is the deck height?
- A2: The deck height is approximately 17 feet above finished floor. Height will ned to be confirmed by General Contractor.
- Q3: Detail 15/A401 calls for a wall here. Is this to be wood framed, or metal studs (same for 13 and 16/A401)
- A3: If you mean the dividers perpendicular to the front of desks between each work station, this divider is to be built as part of the casework unless shown as a wall with a wall type tag on floor plan, drawing sheet 4/A101.
- Q4: Gyp spec calls for a texture finish. Is this required, and if so, what kind of texture?
- A4: The intent is to match existing. There shall be no texture finish. Finish shall be GA-214-96 Level 4 followed by a painted finish.
- Q5: Detail 20/A401 calls for a Fry Reglet. Do you have a part number for this? Or could we have the glazing contractors do this with break metal to match the rest of the system?
- A5: The glazing track should be equal to Fry Reglet DMGT 4875. Who installs it is a means and methods question up to the contractor and their subcontractors.

- Q6: How are we going to fasten the Partition half wall at the entrance (8/A401 and 19/A401)?
- A6: OPN has revised 8/A401 and 19/A401 to show wedge anchors to be embedded into concrete floor to help prevent overturn. The revised detail is issued as part of Addendum 2.
- Q6: Is a serial number or a model number on the access control panel and CCTV (Even a picture could service of these panels or head end units.)?
- A6: Photos are attached of existing equipment per construction documents, equipment is specified to be replaced.

#### PLEASE MAKE THE FOLLOWING CHANGES:

1. Sheet A401 (Rev. 2, Addendum 02, May 20, 2021)

Revised drawing sheet A401 replaces previously issued sheet, revised to show wedge anchor detail to floor for additional stability.




