 - o Public bid opening in DC PW conference room.
- Project commencement by 7-1-11 and completion by 9-1-11
 - o The completion date will be extended if alternate Water Tower is accepted.
- Bonds Insurance
 - o 5% Bid Bond
 - o 100% Performance / Payment Bond
 - o Insurance needs to have Dane County listed as additionally insured.
- Meet qualification requirements
- Fair Labor Practices & BVC
 - o FLP must be submitted with Bid.
 - Contractor will need to be a prequalified BVC prior to signing contract.
- Plans and Specifications on internet or at Dane County Public Works no charge
- Routing of questions, submittals, change orders, and pay requests
 - o Rout questions to Rob Nebel (608/267-0119, nebel@countyofdane.com).
- All permits by contractor
- Parking available
 - Coordinate with Project Engineer.
- Staging Area


- Within construction limits. Coordinate with Project Engineer.
- Utilities
 - o All utilities will be marked by Owner prior to demolition.
 - o All cutting and capping are to be done by Contractor.
- Protection for existing structures to remain: Admin., CFS, BP loading dock entrance
 - o No access on new loading dock for Powerhouse demolition.
- Boilers in Powerhouse to be removed by third party. Coordinate with Owner.
 - See Bid Form in Addendum 2 for new Bid Alternate for these boilers.
- Hazardous Materials: Asbestos removed by owner, Mercury and any other hazardous materials must be disposed of properly by Contractor.
 - Windows containing asbestos will be completely removed by Owner's asbestos contractor.
 - o All paint will need to be tested and disposed of properly by Contractor.
- List of subcontractors
 - Successful Contractor will be required to submit this list if any subcontractors will be utilized.
- Recycling Submittals
 - Submit with any pallets, plastic, etc. noted as recycled during project.
- Prevailing Wage Rates
 - Provided in Bid Documents.
- Work times: 7:00 am 6:00 pm weekdays, schedule with Owner.
 - o Extended work hours are acceptable if approved by Project Engineer.
- Demo Sequence: WW \rightarrow PH \rightarrow H \rightarrow WT
 - o Demolition will be following the abatement in the order provided.
 - Tentative Demo Schedule will be as follows:
 - West Wing (6/1 7/1)
 - Powerhouse (7/5 7/7)
 - Hospital (7/8 7/15)
- Progress meetings: Weekly.
 - Decision making employee and job foreman will be required to attend for each meeting.

- Noise/Dust control
 - The New Badger Prairie Health Care Center will be in use during construction and needs to maintain regular working conditions.
- Work by Owner: Seal up existing buildings to remain, parking lot
 - o Ballasts and lamps need to be removed and placed in Owner-provided barrels before demolition begins. Owner will dispose of these barrels.








Badger Prairie Health Care Center 1100 E. Verona Ave. Verona, Wisconsin 53593

1 SOUTH UNIT 22 BEDS 9/4/00



2 SOUTH UNIT 14 BEDS 9/4/00




