ATTENTION ALL REQUEST FOR BID (RFB) HOLDERS

RFB NO. 315052 - ADDENDUM NO. 1

INSTALLATION OF GAS EXTRACTION WELLS

<u>BIDS DUE</u>: THURSDAY, FEBRUARY 4, 2016 2:00 PM. DUE DATE AND TIME ARE NOT CHANGED BY THIS ADDENDUM.

This Addendum is issued to modify, explain or clarify the original Request for Bid (RFB) and is hereby made a part of the RFB. Contractor must acknowledge this Addendum on Bid Form.

PLEASE MAKE THE FOLLOWING CHANGES:

1. Bid Due Date

The bid due date listed in the advertisement in local newspapers incorrectly said the bids are due *Tuesday*, February 4, 2016. February 4th is not a Tuesday. As stated throughout the rest of the RFB packet, Bids are due Thursday, February 4, 2016 at 2:00 PM.

2. Drill Spoils

Dane County will haul drill spoils to active landfill area for disposal. There shall be no disposal fee for these materials. Contractor shall load the spoils into County haul trucks. Dane County will have two articulated dump trucks available for hauling drill spoils and other materials described below. These trucks shall be able to reach all drilling locations, including locations on the landfill hill slopes.

3. Benches

Dane County will supply benching material and haul it to the drilling locations. Contractor shall build any benches needed to complete Work. Dane County will remove the benches.

4. Backfill Material

If any general fill material is needed for backfilling, Dane County shall supply the material and haul it to the drilling locations.

5. Intermediate Filter Material

The gas well detail includes an "Intermediate Filter". Dane County shall supply this material and haul it to the drilling locations.

6. Pipe Joints

Contractor may NOT use bell end pipes to construct the gas wells. All joints must be smooth inside the gas well, as County needs to be able to lower pumps in these wells after construction and take the pumps back out.

7. Rejection Well Abandonment

In the event the Contractor starts drilling a new well but is unable to complete the well, this rejection well shall be abandoned by placing the drilling spoils back in the drill hole and sealing the drill hole with one bentonite seal at the top.

8. Restoration

Contractor shall restore all disturbed areas. This restoration Work shall include, but not be limited to, grading and seeding disturbed areas to match existing conditions.

9. Site Hours

The landfill site is typically open Monday-Friday from 7am-3pm and Saturdays from 8am-11am. Contractor shall be allowed to Work outside of these hours, if Contractor coordinates schedule with County and obtains County approval. If extended hours are approved, County shall provide dump trucks and truck drivers during the extended hours. Contractor must adhere to City of Madison noise Ordinances with respect to hours of Work.

10. Pipe Material Unloading

Dane County owns a Lull Forklift and can assist Contractor in unloading materials when they arrive at the site.

11. Gas Wells in Capped Areas

Gas wells GW-23 and GW-6 are within areas of the landfill that have received final cap, but there is no plastic component of the cap at these two gas well locations. When completing the well for these two wells, the fill materials, starting from the top ground grades and moving down, shall be: grass, 6" topsoil, 2.5' rooting zone, 2' compacted clay, 1' bentonite seal, and then filter pack material. Contractor shall place all materials in the order described above. County shall provide the clay material and haul it to these two well locations.
