1. Floor Plans

Floor plans were requested and are issued with this Addendum.

2. Misc. Questions:

- a. Will this project be funded through existing budget allocations and/or any available grants (e.g., Focus on Energy, etc.)? If so, what is the projected budget for this ESPC? Yes; approximately \$1,000,000
- b. Has Dane County had a preliminary assessment for the Northport Office by an ESCO? If so, is this considered public record and available for release?

No; this project will include a full, investment grade facility assessment

c. Will Dane County require County Board approval of a project for these capital improvements? This was not a step that was indicated in the Timetable (RSBI – 2. #8).

The DC Board will approve the total ESPC, not individual ESMs & the cost to implement them.

d. Is there an annual energy guarantee of savings required in conjunction to the submittal of the M&V reports? If so, how many years would the guarantee be in force?

Yes; 3 years with options for years 4 & 5

e. Were there any plans, drawings of utility information provided or available to any of the ESCOs?

Yes & no; plans are issued with this Addendum; utility information is not yet available

f. Are there any sustainable and/or renewable energy measures Dane County would wish to consider? If so, that may have an influence on who we would partner with in a joint venture (RSBI – 1, D. 4).


